Rat Control Program (CAP-RCP)

RMs and First Nations bands can apply for rebates up to 50% of approved expenses when active in their rat control efforts and follow the minimum level of service determined by the 2021-22 CAP-RCP.

Please be advised that the Ministry of Agriculture will require notification of any outstanding 2021 municipal

tax Arrears

Section 2-17 of The Provincial Lands Act, 2016:

"that municipalities can request the Ministry of Agriculture to cancel an agriculture lease if taxes remain unpaid for more than five business days after December 31 of the year in which they were levied."

Municipalities are required to fill out the Agreement Cancellation Request Non-payment of Property Taxes Relative to Provincial Land.

tax arrears by **January 31, 2022.** If a municipality fails to submit their request by the January 31 deadline, they will forgo payment by the Ministry of Agriculture.

As a reminder, if the agriculture leaseholder makes their tax payment on the leased land, you should advise our ministry immediately as cancellation proceedings may be stopped.



Investing in SK community, culture and recreation projects



A new detailed application intake process was launched by the Government of Saskatchewan under the Investing in Canada Infrastructure Program (ICIP) for community, culture and recreation projects.

This latest intake has two phases:

- Phase 1 is now open and closes on January 11, 2022. This is for
 projects at the "shovel-ready" stage. These submitted projects will also be
 considered in the second intake phase.
- Phase 2 is also now open and closes May 10, 2022. This is for more complex projects needing extra time to complete applications.

Previously unsuccessful applicants are encouraged to submit eligible project proposals under this new intake for community, culture and recreation infrastructure.

This will be the last opportunity to apply for these types of projects under ICIP in Saskatchewan to allow future intakes to focus on other types of infrastructure.

Eligible recipients are also reminded that applications are still being accepted under a currently open intake for landfill decommissioning projects.

Channel Clearing Assistance

- Rebate Program

The Water Security Agency (WSA) reminds rural municipalities to take advantage of the largest



ever channel clearing rebate program offered by the province. Up to \$1.5 million is available in 2021-22. The cost-sharing program assists rural municipalities to remove obstructions in natural watercourses that can cause flooding and erosion problems to roads and adjacent lands.

WSA has streamlined the program making it simpler and more efficient for applicants. Information about the channel clearing program and application process is found in the program guide or at https://www.wsask.ca/water-programs/channel-clearing/

The first step in the process is to submit the notification form (Appendix A) at least 14 days before beginning any work.

Once the work is finished, complete the rebate application (Appendix B) and submit it with all necessary documentation of expenditures to the nearest **Water Security Agency office** or by emailing **ruralwaterservices@wsask.ca**.

This program only applies to natural watercourses. Constructed works for drainage or moving water are not eligible for the rebate.

To qualify for the program, all rebate applications must be received by WSA on or before January 31, 2022.
