

CANCELLATION OF INSURANCE

(Municipal Hail Insurance Act)

Insurance may be cancelled for the current year ONLY on crops insured which have been destroyed by some cause other than hail, such as wind, drought, grasshoppers, flooding, etc., by notifying the Association by fax or registered letter on or before July 29th.

Where cancellation of insurance is allowed, a credit will be applied against the hail rates charged for the current year. The amount of such credit will depend upon the date when cancellation notice is mailed or faxed.

Cancellation of insurance will not be allowed under the following circumstances:

- a) Fall seeded crops insured for seed production and subsequently cut for feed after May 31st.
- b) Spring seeded crops insured for seed production and subsequently cut for feed after June 30th.
- c) Fodder or seed crops harvested.
