PART IV: NARRATIVE INTERPRETATION OF ABOVE STATISTICS

The following is provided to the Chief, Mayor, Reeve, Administrator, Council or Community Representative on policing initiatives and general policing information. It should be hand delivered whenever possible.

1. Crime trends/problems: (Gangs, Drugs, Domestic Violence, Traffic etc.)

Southey / Strasbourg Detachment responded to 749 calls for service / incidents that occurred within the Detachment area between January 1st and March 31st.

There were 75 calls for service / incidents originated from the RM of McKillop in the first 3 months of this year.

During the pandemic, there has been a decrease in the amount of reported thefts and break and enters within the Southey / Strasbourg Detachment area.

2. Crime Prevention initiatives (school visitation, DARE, programs, interagency/council meetings)

The Southey / Strasbourg RCMP detachment members have had less contact with schools due to the pandemic. As a result of calls from the community of Strasbourg, there has been increased presence in the Strasbourg School area around peak traffic hours to ensure students are abiding by traffic laws and driving safely. Our Traffic Section has met with some of the school bus drivers to address concerns and will be working with them periodically to ensure safe transportation of school kids.

Strasbourg Detachment continues to complete criminal record checks. People requiring a criminal record check must call ahead and schedule an appointment to have the check completed. The front door to the detachment is locked and people requiring assistance must call the office at which time they will be screened and allowed inside the detachment if required.

Over the winter, RCMP members patrolled Last Mountain Lake by snowmobile on several occasions.

In the upcoming months, there will be increased RCMP patrols and presence within the resort communities. Our focus will be on traffic and ATV safety and will involve education and enforcement.

Cpl. Jeremy Smith recently spoke to the RM through Zoom at one of the RM Council Meetings.

Consultation has been held with most of our elected officials / communities to discuss areas of concern and to assist us in setting priorities and objectives for the upcoming 2021-2022 Annual Performance Plan. We will continue to focus on crime reduction / prevention and traffic safety.

We hope that as people receive vaccinations for the pandemic that case numbers decline and things return to normal. This would allow our detachment to be more involved in our schools and communities.

3. Feed Back on Police Management Board Meetings (issues / concerns)

The fourth quarter of our 2020/21 reporting year is complete.

Southey / Strasbourg Detachment has begun their new Annual Performance Plan, which commenced in April 2021. Each community and Rural Municipality have been contacted and asked for input to assist in the planning process. Due to the Pandemic, no Town Hall meetings or Community Consultative Group Meetings were held over the past 12 months.

4. Other significant issues: (infrastructure, resources, change administration)

Southey/Strasbourg Detachment has a total of 10.5 positions. The Detachment complement includes: 1 Sargent, 1 Corporal, 6 Constables, 1 Community Constable, 1 Full time Public Servant in Southey and 1 - part time Public Servant in Strasbourg.

Cst. Justin Pak has transferred from the Southey Detachment and started his new posting in February 2021.

Cst. Brandyn McCartney is transferring to the Southey Detachment from the North West Territories and will be starting in February 2021.

S/Cst. Jack Clay has resigned from the RCMP. His position as the Community Constable will not be filled.

We presently have 2 vacant constable positions. Sgt. Gherasim is in contact with our Human resources (staffing) and hope to have 1 of the positions filled in the near future.

5. Document feedback from Mayor/Reeve and Council: (Issues / Concerns)

Southey/Strasbourg Detachment tries to have regular contact with the elected officials in the communities we police. We encourage our community leaders to provide the detachment with any issues or concerns that are present in the community. Please feel free to contact myself or

any other member of the Detachment.
