

A BYLAW OF THE RURAL MUNICIPALITY OF MCKILLOP NO. 220 TO AMEND BYLAW NO. 398/2020 BEING A BYLAW TO ESTABLISH A MAIL-IN BALLOT VOTING SYSTEM

The Council of the Rural Municipality of McKillop No. 220 in the Province of Saskatchewan enacts as follows:

This bylaw shall amend Bylaw No. 398/2020 as follows:

- 1. Amend Section 4 to add who may witness Schedule A and Schedule B to include the following:
 - f) a person who is of at least eighteen (18) years of age and has known the applicant voter for two years or more;
 - g) a person who is of at least eighteen (18) years of age and who is related to the applicant voter and has known the applicant voter for two years or more in one of the following ways:
 - spouse, father, mother, grandfather, grandmother, stepfather, stepmother, father-in-law, mother-in-law, brother, sister, brother-in-law, sister-in-law, son, daughter, stepson, stepdaughter, son-in-law, daughter-in-law, grandson, granddaughter, common-law partner.

No candidate or candidate's agent shall witness the voter's signatures on the Voters Registration Form or Declaration of Person Requesting Mail-IN Ballot Form.

2. Add Section 4.1 as follows:

Due to the COVID 19 Pandemic Schedule A (Form R) and Schedule B (Form C) received prior to the approval date and adoption of this bylaw have been reviewed and deemed authentic by the Returning Officer.

3. Remove and replace SCHEDULE B Appendix A to add witness name, address and phone number as attached to and forming part of this bylaw.
