

To vote in the upcoming Federal Election, you must be a Canadian citizen, be at least 18 years old on election day, and prove your identity and address.


Elections Canada is asking people to plan early. During a pandemic, things can take a bit more time. Make a plan and choose the voting option that works best for you.

Rural Municipal Administrator Scholarship - Apply by October 15

The application intake for the 2021 Rural Municipal Administration Scholarship Program is currently underway. This program is for students enrolled in the Local Government Authority (LGA) Certificate Program at the University of Regina.

Three scholarships of \$1,000 each are awarded annually, paid at the end of the completed semester. Selection is based on academic achievement, demonstrated interest in administration as a career in rural Saskatchewan, contributions to and knowledge of rural Saskatchewan, and other criteria.

Applications must be received in the SARM office no later than October 15, 2021.



Invasive Plant Control Program (CAP-IPCP)

RMs, FNBs, and Producers/Stakeholders can apply for rebates of up to 50% of the cost of approved herbicides used to treat prohibited & select noxious weeds through the CAP-IPCP.



Targeted Sector Support Initiative Cost-Shared Grants

The Targeted Sector Support (TSS) Initiative is a portion of Municipal Revenue Sharing (\$1.5 million per fiscal year) that provides cost-shared grants (up to 75 per cent on eligible costs) to municipalities partnering to strengthen their core municipal responsibilities through projects focused on regional co-operation, capacity building, good governance, and the priorities set by the TSS Steering Committee.

The Steering Committee consists of representatives from the Saskatchewan Urban Municipalities Association (SUMA), the Saskatchewan Association of Rural Municipalities (SARM), the Saskatchewan Association of Northern Communities (New North), and the Ministry of Government Relations.

Sharing Resources, Serving Residents: The Town of Willow Bunch received a TSS grant of more than \$14,000 to support a combined asset management review and system update in collaboration with the RM of Willow Bunch.

Supporting Good Governance: The RM of Frenchman Butte received \$13,000 to provide municipal governance training to elected officials in the RM, as well as officials from the following surrounding municipalities: Village of Paradise Hill, Town of St. Walburg, RM of Mervin, and RM of Britannia.

Promoting Regional Collaboration and Safety: The City of Meadow Lake received over \$37,000 to conduct a regional fire and emergency services feasibility study with the neighbouring RM of Meadow Lake and Flying Dust First Nation.



Rural Crime Watch

Rural Crime Watch (RCW) is a community driven, community led, police supported crime prevention and reduction collaborative program. The Rural Crime Watch program in Saskatchewan is a partnership between the Provincial Rural Crime Watch Association (includes local RCW boards where they exist), the RCMP, and its authorized Protection and Response Team (PRT).

The RCMP's PRT partners include Saskatchewan Conservation Officer Services and Saskatchewan Highway Patrol. RCW members are volunteers who serve as the 'Eyes and Ears' of their communities and contact the police to report suspicious persons / vehicles.







- In December 2020, One Arrow First Nation received \$7,690 to fund the purchase and installation of speed display signs. After applying again in 2021, they've received another \$19,497 from the Provincial Traffic Safety Fund Grant to install solar-powered streetlights in the community.
- After getting public feedback through a traffic safety survey, Kinistin Saulteaux Nation applied for a Provincial Traffic Safety Fund Grand and received \$11,522 to install traffic-calming speed display signs in their community.



Supporting a Colleague Mental Health as a First Responder

Maintaining mental health can be a challenge in the best of times. Ongoing stressful situations can significantly amplify mental health issues. Working to serve others during the pandemic has intensely magnified mental health challenges for many public safety personnel (PSP), including paramedics, border services officers, police, 911 communicators/dispatch, correctional workers, and firefighters among others.



Signs of mental health struggles can include:

- · Withdrawal from the group;
- Decrease in productivity;
- Difficulties relaxing;

- Regularly low mood, frequent pessimistic comments;
- Increased sensitivity to stimuli (e.g., light, odours, sounds);
- · Lack of interest in work, colleagues, or pleasant activities outside of work;
- Difficulties concentrating and thinking;
- · Illusions, suspicion, or paranoia;
- Abnormal or unusual behaviour;
- Reports of lost sleep, too much sleep, or fatigue;
- · Reports of low or increased appetite;
- Changes in personal hygiene, particularly reductions in hygiene; and
- · Suicidal thoughts, comments, or behaviour.

Burnett said friends and colleagues can assist struggling PSP by:

- · reminding them that talking can be helpful;
- listening to them without solutioning;
- asking how you can help;



- asking hard questions if warranted i.e. "are you having thoughts of suicide?";
- · reminding them you are there; and
- encouraging them to seek professional help.

Burnett urges all PSP struggling with depression, anxiety, or posttraumatic stress, to contact PSPNET. She also urges PSP looking to keep themselves healthy to apply for the program. PSPNET is an internet-delivered mental health support program. It is free, confidential, and does not require a referral or a diagnosis, eliminating the need to advise employers or colleagues of your participation in the program.

In addition, there are **no wait times** to access services. The program combines online learning modules with weekly email or telephone support.

If you are, or know of, a current or former PSP, who is experiencing symptoms such as depression, anxiety, or posttraumatic stress, please encourage them to access the program by visiting **www.pspnet.ca** or calling 306-337-7233 or 1-833-317-7233.



Stress on the farm

Rural families deserve credit for working hard to meet the challenges that are often beyond their control such as weather, pests, disease, high-input costs, volatile markets and low financial returns at the farm gate. Many Saskatchewan farm families have off-farm income, which, in turn, may result in additional pressure which can lead to fatigue and burnout.

Farmers and ranchers who endure high levels of stress may find that it has negatively affected their health and has reduced their quality of life. High stress can compromise personal safety and affect family relationships.

Whether it is information, conflict, or crisis, the first step is communication. Call before the problem becomes a crisis. The Farm Stress Line can help if you are managing farm difficulties by providing support for farmers and ranchers.

We respect confidentiality. There is no call display.

Rural Integrated Roads for Growth

Application Intake for the 2022-2023 Rural Integrated Road for Growth Program (RIRG)

Applications for the Road Construction Program and the Bridge and Large Diameter Culvert Initiative remains open for the 2022-2023 Rural Integrated Rods for Growth (RIRG) Program. The application intake closes October 29, 2021.

All previously ranked and eligible project applications will be added to the 2022-2023 intake for consideration.

Applications will be completed using the digital forms that can be found on the RIRG section of SARM's website at https://sarm.ca/programs/rirg. For full details on the eligibility of projects, please see the RIRG Policy Manual.

Projects located on roadways with a Rural Road Classification of Class 3, 4, 5, and 6 will be eligible to apply and it shall be mandatory that all projects be built to the standards described in the RIRG Policy Manual.

Projects are to be engineered and shall be designed and constructed to the applicable requirements and standards described in the RIRG Policy Manual.

Procurement following the New West Partnership Trade Agreement is mandatory. Thresholds for the public procurement for engineering is \$75,000 and for construction is \$200,000.

It is recommended by the RIRG Program that the Municipality engage the services of an Engineering Consultant to provide an engineered estimate of the total project to ensure accurate costs.

Approximately \$14 million in Ministry of Highways stimulus funding is to be allocated to Road Construction Projects and approximately \$12.5 million in funding is available for the Bridge and Large Diameter Culvert initiative in 2022-23.

Maximum grant funding for each project is determined from the estimated project costs submitted by the Municipality on the project application. All grants provided by the RIRG are 50% of eligible costs up to maximum of \$500,000.

SARM Disability Benefits Ending Special Coverage for COVID-19 Isolation Claims

Please be advised that effective September 1, 2021, SARM Disability Benefits will no longer cover COVID-19 isolation claims. This coverage came into effect in March 2020 as a way to help prevent the spread of COVID-19 in Saskatchewan. With widespread vaccine availability for everyone ages 12 and over, recent changes to Public Health rules for self-isolation, and the continued existence of federal assistance programs such as the Canada Recovery Sickness Benefit, the need for this initiative has passed.

If an employee is COVID-19 positive and meets the Plan's definition of disability through symptomatic illness or hospitalization, this could be an eligible disability claim, subject to the standard assessment of submitted medical information (i.e. Employer Statement, Employee Statement and Attending Physician Statement).
