**PART IV: NARRATIVE INTERPRETATION OF ABOVE STATISTICS**

**The following is provided to the Chief, Mayor, Reeve, Administrator, Council or Community Representative on policing initiatives and general policing information. It should be hand delivered whenever possible.**

---

**1. Crime trends/problems: (Gangs, Drugs, Domestic Violence, Traffic etc.)**

Southey / Strasbourg Detachment responded to **688** calls for service / incidents that occurred within the Detachment area between July 1<sup>st</sup> and September 30<sup>th</sup> of this year. In comparison, Southey/Strasbourg responded to **778** calls for service/ incidents during this same reporting period last year(2020).

There were **143** calls for service / incidents originated from the RM of McKillop during this reporting period. The calls for service were therefore up significantly as there were **53** calls for service / incidents between January-March of 2021 and **113** calls for service / incidents from April-June of 2021. The upswing in calls for service during the past three months can be attributed to enforcement under the *Traffic Safety Act(TSA)* during the summer months as there were **103** reported calls for service/incidents which resulted in **74** charges being laid under the TSA.

**2. Crime Prevention initiatives (school visitation, DARE, programs, interagency/council meetings)**

Southey/Strasbourg Detachment continues to complete criminal record checks. The front door of the office is no longer locked as a result of the pandemic and people can attend the office and request Criminal Record checks.

Consultation continues with our elected officials / communities to discuss areas of concern and to assist us in achieving our priorities and objectives which were set for the 2021-2022 Annual Performance Plan. We will continue to focus on crime reduction / prevention and traffic safety. We hope to become more involved in our schools and communities as the number of vaccinations increase and the number of COVID cases decrease.

**3. Feed Back on Police Management Board Meetings (issues / concerns)**

Southey / Strasbourg Detachment has begun their new Annual Performance Plan, which

commenced in April 2021. Each community and Rural Municipality have been contacted and asked for input to assist in the planning process. Due to the Pandemic, no Town Hall meetings or Community Consultative Group Meetings were held over the past 12 months.

#### **4. Other significant issues: (infrastructure, resources, change administration)**

Southey/Strasbourg Detachment has a total of 9.5 positions. The Detachment compliment includes: 1 Sergeant, 1 Corporal, 6 Constables, 1 Full time Public Servant in Southey and 1 - part time Public Servant in Strasbourg. There is 1 Cst. Position that is currently vacant and one member is currently on light duties until the end of November.

After 6 ½ years Sgt. Dean Gherasim was transferred from Southey Detachment and started a new posting at Lumsden Detachment at the end of July 2021. Sgt. Doug MacDougall was named as his replacement and began his new position in Southey on October 7<sup>th</sup>. Sgt. MacDougall, however, has been promoted to another position and will therefore be transferred near the end of November. A new Sgt. has been identified and the transition between Sergeants is expected to be done quickly/seamlessly.

Sgt. MacDougall has been in contact with our Human resources (staffing) and hopes to have the vacant position filled in the near future.

Southey/Strasbourg Detachment tries to have regular contact with the elected officials in the communities we police.
