

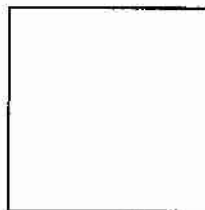

<https://www.skparcs.com> and click on NEWSLETTERS at the top of the front page. You will find that all of our Constant Contact newsletters are filed there. Although it says NO FILE LISTED, all you have to do is **CLICK ON THE RED TITLE** of that newsletter; it will open up (it's the constant contact address, hidden behind it name).

**QUESTION #2 - Am I able to look at other resort village BYLAWS?**

**IF YOU WOULD LIKE TO BROWSE OTHER RVs' BYLAWS**, again - just go to our WEBSITE. This time, look on the bottom right of the front page and click on **RESOURCE DOCUMENTS**. Go down the list until you find the title of **RESORT VILLAGE WEBSITES**. A summary chart will come up showing all of the resort villages. You will note that 33 resort villages have websites. You will also note that 28 of these resort villages have links to their websites. Take some time to browse through a few of these to see if you can find examples of the bylaws you are considering.

**QUESTION #3 - What about looking at other resort village POLICIES?**

These are easy to find. Again, go to the PARCS Website. Again, look at the top of the page for the title, **POLICIES**. When you click on this heading, you will find 51 policies that resort villages volunteered to share with other resort villages - just click on the links.

- **At the Hilton Garden Inn in Saskatoon**

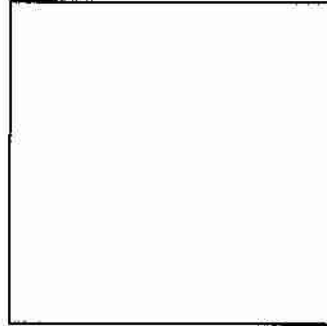
