**Minutes of the Spring Meeting Saturday**

**Opening:**

**Old Business:**

- a) Bob Bell reported repairs were made to the pier @ a cost of \$836.00 and North Colesdale will pay half. Bob approached the R.M. for help with cost of pier and boat launch maintenance as others are using the boat launch. The request was denied.
- b) Copies of PARCS's news were passed around for viewing. John Surkan made a motion to join, seconded by Ken McDowell. **Carried**
- c) Two new water boxes were installed this year by John Surkan.
- d) John Surkan shocked the well and Gary Tamlin will have the water tested.
- e) Bob Bell built steps and placed them at the garbage bins for easier and safer access to the bins.
- f) The roads were to be surfaced last week but due to break down of equipment this has not yet been done. Roads will be surfaced A.S.A.P..
- g) Bob Bell reported on the picnic shelter which is partially built. People have requested metal siding be used inside and out for easy maintenance. Scott Meier made this a motion, seconded by Joe Matz. **Carried**
- h) Snow removal discussion. Dale Renwick made a motion to get whoever is available to remove snow, seconded by Curtis Jerome **Carried**

**New Business:**

- a) Bob Bell suggested we put chains on posts around public reserve to keep vehicles out, a discussion followed. Bonnie Brandvold made a motion to put up chains at a cost not to exceed \$500. Dale Renwick seconded. **Carried**
- b) A discussion was held on putting up a Colesdale Park sign on the Public Reserve so it can be viewed from the lake. Scott Meier proposed a design at a cost of approx. \$2000.00. Ronda Renwick made a motion to have a sign made for a cost not to exceed \$2000.00, seconded by Will Fry. **Carried**
- c) A discussion was held on installing speed bumps on the east road. Terry Abrams made a motion to have three speed bumps installed if it is legal, seconded by Will Fry. **Carried**

- d) Bob Bell reported the sand on the public beach has been washed away, a discussion followed. The general consensus was to do nothing at this time.
